Operating at the intersection of faith and development, CIFA is committed to harnessing the potential of the faith sector as a positive force for global development. CIFA does this through increased interfaith coordination, best practices and model sharing, innovative mobilization of resources, and influential advocacy to governments and the general public.

## Letter from CIFA's Founder and Chairman, Mr. Edward W. Scott, Jr.

Dear Friends,

I started CIFA in September 2008 because I saw a huge gap in the development landscape and believe that the faith community, with its reach, credibility and moral authority, has the capacity to go the last mile to serve its congregations — in effect acting as a complementary global health delivery system.

With significant help from our partners in the faith and development communities, CIFA has made great progress in fulfilling its mission to improve the capacity and effectiveness of the faith sector in its collective effort to reduce poverty and disease. CIFA has done this by developing an effective and sustainable national-scale coordinating mechanism between the faith community and the public sector so the full capacities of the religious institutions can be engaged in national social welfare programs.

CIFA's innovative approach has been to create and shape a new model for action to systematically support and shape the work of faith leaders and faith-based organizations to more effectively address critical health issues in the developing world.

Our programs have made noteworthy advances in meeting their goals to promote interfaith action, while demonstrating the effectiveness of the faith sector as a credible development partner, securing and mobilizing resources for the sector, and supporting the communities' voice to build capacity both domestically and in the developing world.

CIFA, through its creation of a local NGO partner, the Nigerian Inter-faith Action Association (NIFAA), is now operating a malaria eradication program in Nigeria. We have engaged Nigeria's top Muslim and Christian leaders, the Sultan of Sokoto and The Catholic Archbishop of Abuja, to co-chair NIFAA, in what may be the largest development partnership between the two faiths in history. NIFAA has also developed a strong partnership with Nigeria's national malaria control program, and will play a key role in helping the government increase mosquito net distribution and utilization.

Other critical areas CIFA has been supporting are helping to make the case for investment in the faith sector through our series of consultations, with leaders of faith-based development organizations and other development visionaries.

I look forward to reporting back to you on CIFA's progress and the activities of our partners in the coming months. It is sure to be a promising future as we all seek to reach the Millennium Development Goals and end poverty and suffering around the world.

**INTERFAITH ACTION:** Leveraging the capacity of the global faith sector to effectively support delivery of global health systems and improving the effectiveness of the religious sector through interreligious collaboration, scaling-up and replication.
